Who it's for

The service is designed for retail clients who are US taxpayers and are advised by advisers who are fully regulated in the relevant jurisdiction.

The Praemium US Taxpayer Service is available in many jurisdictions*, and is appropriate for investments in GIAs, ISAs, UK SIPPs, or international pension structures such as OROPS or ONUPS.

We are not currently able to offer US pension schemes (e.g. IRAs) on the platform.

Accessing the Service

Praemium provides two options for accessing the US taxpayer service.

- Where an adviser firm has only one or two US tax payers, we offer a Praemium branded US service.
- For larger firms who have a higher percentage of US taxpayers, Praemium provides an adviser-branded service. This service is available to firms when they reach £10 million in FUM on the US Service, or can be bundled with other services via the platform.

Getting started

For the firm:

To gain access to the US Taxpayer Service, you will need to complete:

- Registration Form
- Adviser Firm Schedule

We will conduct our standard due diligence on your firm, and once approved, will provide a short training session on using the platform and ongoing support as needed.

For the investor:

It's easy to set up accounts online for your investors via the adviser portal, which also includes digital acceptance so the entire process can be handled remotely.

Once money has been received, we will make the investments for their account in accordance with the model(s) you select.
